GENERAL NOTES

Laboratory investigations that include the use of scientific inquiry, research, measurement, problem solving, laboratory apparatus and technologies, experimental procedures, and safety procedures are an integral part of this course. The National Science Teachers Association (NSTA) recommends that at the high school level, all students should be in the science lab or field, collecting data every week. School laboratory investigations (labs) are defined by the National Research Council (NRC) as an experience in the laboratory, classroom, or the field that provides students with opportunities to interact directly with natural phenomena or with data collected by others using tools, materials, data collection techniques, and models (NRC, 2006, p. 3). Laboratory investigations in the high school classroom should help all students develop a growing understanding of the complexity and ambiguity of empirical work, as well as the skills to calibrate and troubleshoot equipment used to make observations. Learners should understand measurement error; and have the skills to aggregate, interpret, and present the resulting data (National Research Council, 2006, p.77; NSTA, 2007).

Instructional Practices

Teaching from a range of complex text is optimized when teachers in all subject areas implement the following strategies on a routine basis:

1. Ensuring wide reading from complex text that varies in length.
2. Making close reading and rereading of texts central to lessons.
3. Emphasizing text-specific complex questions, and cognitively complex tasks, reinforce focus on the text and cultivate independence.
4. Emphasizing students supporting answers based upon evidence from the text.
5. Providing extensive research and writing opportunities (claims and evidence).

Describe and explain what characterizes science and its methods.

Remarks/Examples:
 Science is characterized by empirical observations, testable questions, formation of hypotheses, and experimentation that results in stable and replicable results, logical reasoning, and coherent theoretical constructs.

Recognize that the strength or usefulness of a scientific claim is evaluated through scientific argumentation, which depends on critical and logical thinking, and the active consideration of alternative scientific explanations to explain the data presented.

Remarks/Examples:
 Assess the reliability of data and identify reasons for inconsistent results, such as sources of error or uncontrolled conditions.

Identify sources of information and assess their reliability according to the strict standards of scientific investigation.

Remarks/Examples:
 Read, interpret, and examine the credibility and validity of scientific claims in different sources of information, such as scientific articles, advertisements, or media stories. Strict standards of science include controlled variables, sufficient sample size, replication of results, empirical and measurable evidence, and the concept of falsification.

Describe and provide examples of how similar investigations conducted in many parts of the world result in the same outcome.

Remarks/Examples:
 Recognize that contributions to science can be made and have been made by people from all over the world.

Describe how scientific inferences are drawn from scientific observations and provide examples from the content being studied.

Remarks/Examples:
 Collect data/evidence and use tables/graphs to draw conclusions and make inferences based on patterns or trends in the data.

Recognize the role of creativity in constructing scientific questions, methods and explanations.

Remarks/Examples:
 Work through difficult problems using creativity, and critical and analytical thinking in problem solving (e.g. convergent versus divergent thinking and creativity in problem solving).

Identify what is science, what clearly is not science, and what superficially resembles science (but fails to meet the criteria for science).

Remarks/Examples:
 Science is the systematic and organized inquiry that is derived from observations and experimentation that can be verified or tested by further investigation to explain natural phenomena (e.g. Science is testable, pseudo-science is not science seeks falsifications, pseudo-science seeks confirmations.)

Identify which questions can be answered through science and which questions are outside the boundaries of scientific investigation, such as questions addressed by other ways of knowing, such as art, philosophy, and religion.

Remarks/Examples:
 Identify scientific questions that can be disproved by experimentation/testing. Recognize that pseudoscience is a claim, belief, or practice which is presented as scientific, but does not adhere to strict standards of science (e.g. controlled variables, sample size, replicability, empirical and measurable evidence, and the concept of falsification).

Identify examples of pseudoscience (such as astrology, phrenology) in society.

Scientific knowledge can change because it is often examined and re-examined by new investigations and scientific argumentation. Identify possible bias in qualitative and quantitative data analysis.</p>

A number of shared values and perspectives characterize a scientific approach.</p> <p>MAFS.K12.MP.1: Make sense of problems and persevere in solving them, and MAFS.K12.MP.2: Reason abstractly and quantitatively.</p>
SC.912.P.8.1:	<p>Differentiate among the four states of matter.</p> <p>Remarks/Examples: Differentiate among the four states of <u>matter</u> (solid, <u>liquid</u>, <u>gas</u> and plasma) in terms of <u>energy</u>, particle <u>motion</u>, and phase transitions. (Note: Currently five states of <u>matter</u> have been identified.)</p>
SC.912.P.8.4:	<p>Explore the scientific theory of atoms (also known as atomic theory) by describing the structure of atoms in terms of protons, neutrons and electrons, and differentiate among these particles in terms of their mass, electrical charges and locations within the atom.</p> <p>Remarks/Examples: Explain that <u>electrons</u>, protons and <u>neutrons</u> are parts of the <u>atom</u> and that the <u>nuclei</u> of <u>atoms</u> are composed of protons and <u>neutrons</u>, which experience <u>forces of attraction</u> and repulsion consistent with their charges and masses.</p> <p>Florida Standards Connections: MAFS.K12.MP.4: <u>Model</u> with mathematics.</p>
SC.912.P.10.4:	<p>Describe heat as the energy transferred by convection, conduction, and radiation, and explain the connection of heat to change in temperature or states of matter.</p> <p>Remarks/Examples: Explain the mechanisms (<u>convection</u>, <u>conduction</u> and radiation) of <u>heat</u> transfer. Explain how <u>heat</u> is transferred (<u>energy in motion</u>) from a region of higher temperature to a region of lower temperature until equilibrium is established. Solve problems involving <u>heat</u> flow and temperature changes by using known values of specific <u>heat</u> and/or phase change constants (latent <u>heat</u>). Explain the phase transitions and temperature</p>

	changes demonstrated by a heating or cooling curve.
SC.912.P.10.9:	Describe the quantization of energy at the atomic level. Remarks/Examples: Explain that when electrons transition to higher energy levels they absorb energy, and when they transition to lower energy levels they emit energy. Recognize that spectral lines are the result of transitions of electrons between energy levels that correspond to photons of <u>light</u> with an energy and <u>frequency</u> related to the energy spacing between levels (Planck's relationship $E = hv$).
SC.912.P.10.11:	Explain and compare nuclear reactions (radioactive decay, fission and fusion), the energy changes associated with them and their associated safety issues. Remarks/Examples: Identify the three main types of radioactive decay (alpha, beta, and gamma) and compare their properties (composition, <u>mass</u> , charge, and penetrating power). Explain the concept of half-life for an isotope (e.g. C-14 is used to determine the age of objects) and calculate the amount of a radioactive substance remaining after an integral number of half-lives have passed. Recognize that the <u>energy</u> release per gram of material is much larger in nuclear <u>fusion</u> or <u>fission</u> reactions than in chemical reactions due to the large amount of <u>energy</u> related to small amounts of <u>mass</u> by equation $E=mc^2$.
SC.912.P.10.18:	Explore the theory of electromagnetism by comparing and contrasting the different parts of the electromagnetic spectrum in terms of wavelength, frequency, and energy, and relate them to phenomena and applications. Remarks/Examples: Describe the <u>electromagnetic spectrum</u> (i.e., radio waves, microwaves, <u>infrared</u> , <u>visible light</u> , <u>ultraviolet</u> , <u>X-rays</u> and gamma rays) in terms of <u>frequency</u> , <u>wavelength</u> and <u>energy</u> . Solve problems involving <u>wavelength</u> , <u>frequency</u> , and <u>energy</u> .
SC.912.P.10.19:	Explain that all objects emit and absorb electromagnetic radiation and distinguish between objects that are blackbody radiators and those that are not. Remarks/Examples: Recognize the Planck function allows examination of the radiation emitted by an object as a function only of its temperature.
SC.912.P.10.20:	Describe the measurable properties of waves and explain the relationships among them and how these properties change when the wave moves from one medium to another. Remarks/Examples: Describe the measurable properties of waves (<u>velocity</u> , <u>frequency</u> , <u>wavelength</u> , amplitude, period, reflection and refraction) and explain the relationships among them. Recognize that the source of all waves is a <u>vibration</u> and waves carry <u>energy</u> from one place to another. Distinguish between transverse and longitudinal waves in mechanical media, such as springs and ropes, and on the earth (seismic waves). Describe sound as a longitudinal wave whose speed depends on the properties of the medium in which it propagates.
SC.912.P.10.21:	Qualitatively describe the shift in frequency in sound or electromagnetic waves due to the relative motion of a source or a receiver. Remarks/Examples: Describe the apparent change in <u>frequency</u> of waves due to the <u>motion</u> of a source or a receiver (the Doppler effect).
SC.912.P.10.22:	Construct ray diagrams and use thin lens and mirror equations to locate the images formed by lenses and mirrors. Remarks/Examples: Use examples such as converging/diverging lenses and convex/concave mirrors. Use a ray diagram to determine the approximate location and size of the image, and the mirror equation to obtain numerical information about image distance and image size.
SC.912.P.12.2:	Analyze the motion of an object in terms of its position, velocity, and acceleration (with respect to a frame of reference) as functions of time. Remarks/Examples: Solve problems involving distance, <u>velocity</u> , speed, and <u>acceleration</u> . Create and interpret graphs of 1-dimensional <u>motion</u> , such as position versus time, distance versus time, speed versus time, <u>velocity</u> versus time, and <u>acceleration</u> versus time where <u>acceleration</u> is constant. Florida Standards Connections: MAFS.912.N-VM.1.3 (+) Solve problems involving velocity and other quantities that can be represented by vectors.
SC.912.P.12.4:	Describe how the gravitational force between two objects depends on their masses and the distance between them. Remarks/Examples: Describe Newton's <u>law</u> of universal gravitation in terms of the <u>attraction</u> between two objects, their masses, and the inverse square of the distance between them.

Remarks/Examples: Explain that <u>angular momentum</u> is rotational analogy to linear <u>momentum</u> (e.g. Because <u>angular momentum</u> is conserved, a change in the distribution of <u>mass</u> about the <u>axis</u> of rotation will cause a change in the rotational speed [ice skater spinning]).

Remarks/Examples: Recognize that regardless of the speed of an observer or source, in a <u>vacuum</u> the speed of <u>light</u> is always c .
