Course Information:	<p>In Algebra 2, instructional time will emphasize five areas:</p> <ol style="list-style-type: none">(1) extending arithmetic operations with algebraic expressions to include radical and rational expressions and polynomial division;(2) graphing and analyzing functions including polynomials, absolute value, radical, rational, exponential and logarithmic;(3) building functions using compositions, inverses and transformations;(4) extending systems of equations and inequalities to include non-linear expressions and(5) developing understanding of the complex number system, including complex numbers as roots of polynomial equations. <p><i>All clarifications stated, whether general or specific to Algebra 2, are expectations for instruction of that benchmark.</i></p> <p>Curricular content for all subjects must integrate critical-thinking, problem-solving, and workforce-literacy skills; communication, reading, and writing skills; mathematics skills; collaboration skills; contextual and applied-learning skills; technology-literacy skills; information and media-literacy skills; and civic-engagement skills.</p>
