



**School/Project:** Royal Palm School Addition

Recommendation: I recommend the ½-Cent Sales Tax Oversight Committee approve the

Proposed Plan Modification revising the project budget for Royal Palm

School Addition from \$6,507,704 to \$24,161,894.

## **Description of Proposed Modification:**

This action revises the project budget.

## **Reason for Modification:**

Date: September 7, 2005

- Royal Palm School is a school for children and adults ages 3 through 22 who are physically and mentally handicapped.
- This school currently has thirty-one (31) portables. The original project budget was set up to simply replace the portables with classrooms, however when the educational specifications were prepared for the addition it was clear that the school needs much more than just classrooms. The school also needs additional space in the media center, cafeteria and administrative offices.
- Because of the special needs of the students many of them have a full-time assistant, which means a considerable amount of space is needed even though there are less students in each classroom.
- A separately funded \$4.5 million air conditioning replacement project is also now being combined with this project.
- Building the entire project at one time will save the cost of remobilization and an additional two years of inflation.

## **Additional Considerations:**

• The school was built in 1986 and sits on a 20 acre campus.

## **Description of Proposed Modification:**

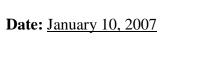
#### **Reason for Modification:**

**Date:** April 28, 2006

- The opening date is being changed because the District had to re-advertise for an architect after the project changed from an addition and remodeling project to a complete replacement. The change in scope was too substantial to simply issue a change order to the previous architect.
- A recently completed study by PBS&J which was commissioned by the Miami-Dade School District revealed that inflation in the Southeast Florida construction market increased an average of 46% between 2003 and 2005. We are still seeing annual inflation rates near or above the 20% mark between 2005 and 2006.
- According to the PBS&J report, factors contributing to these unprecedented inflation rates include, but are not limited to:
  - o multiple hurricanes,
  - o strong construction market,
  - o large capital improvement programs (schools, airports, rail, etc.) in the area,
  - o significant material price increases (ex. oil, cement, steel)
  - o limited pool of qualified, bondable contractors and subcontractors,
  - o limited pool of trade workers,
  - o increased cost of insurance
- Contractors are also reporting that the implementation of the Jessica Lunsford Act is also driving up prices as several subcontractors have indicated that they either can not or will not bid on District projects due to the fingerprinting and screening requirements. We have had two projects where we have had to go with the second lowest bidder for a particular trade and in each case the price increased by nearly \$200,000.

## **Additional Considerations:**

The evaluation committee completed the selection process for the architect on April 21<sup>st</sup>.

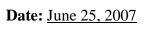
## **Description of Proposed Modification:**

This action revises the project budget, but does not affect the opening date.

#### **Reason for Modification:**

- At the time previous budget was developed for the replacement school the educational specifications were not revised to reflect the district's decision to replace the school rather than build an addition. Since that time several meetings have taken place between district office staff, the school, the architect and the construction manager to finalize the needs of the school. Spaces there were inadequate that were not being addressed with the addition are now going to be replaced with the replacement of the school.
- Recent estimates for this special school indicate that the GMP will come in around \$230 per square foot. Note that this school includes several special features such as a therapy pool and rail systems to lift and transfer disabled students.

- A substantial portion of the additional funding is coming from the Construction Contingency budget for Suncoast High School.
- This project is currently in the design phase.

- The project required additional value engineering to reduce the cost to work within the available budget. The design changes have reduced the cost, however, there has been an impact to the schedule.
- There are very few times during the year that schools can move from their old buildings into new buildings (i.e. Summer Break, Winter Break and Spring Break). This is especially true with the fragile population at this school. We do not believe that we can make the August 2008 opening so we are now targeting January 2009.

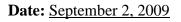

## **Reason for Modification:**

- 1. This action revises the project budgets, timing of funding and opening dates for various projects in accordance with the FY 2008-2012 Five-Year Capital Plan approved by the School Board on September 5, 2008.
- The budgets included in the FY 2008-2012 Five-Year Capital Plan reflect the most recently awarded projects of similar scope plus a reasonable annual inflation rate. Additional funds have been placed in Construction Contingency for unanticipated increases.
- 3. Budget changes are typically for one of the following reasons: (1) reflect latest design phase (Schematic Design, Design Development or Construction Documents) estimate or negotiated Guaranteed Maximum Price, (2) reflect negotiated change orders, or (3) reflect revised inflation assumptions.
- 4. The only scope changes are: (1) reduction of the new Riviera Beach HS (03-MMM) from a 1,800 to 1,500 student capacity, and (2) increase planned capacity of Manatee ES Addition from 970 to 1,200 students.
- 5. The opening dates were revised for projects were revised due to issues associated with site acquisition in addition to funding. This is the case with the Pahokee Stadium, Pahokee Area MS (03-MM), and Royal Palm Beach Area ES (03-W).
- 6. The changes proposed are in large part the result of the need to cut approximately \$212 million from the 5-Year Capital Plan due to actual and projected decreases in funding as well and lower enrollment projections. Property tax, impact fees and Class Size Reduction revenues for FY 2008 were all lower than previously projected.
- 7. Staff implemented a prioritization process which was thoroughly feted amongst the School Board Members at several public meetings.
- 8. These changes are essentially the same as those presented to the ISSOC at the June 25, 2007 ISSOC Meeting. There have been no changes to the opening dates of any projects since that meeting, however, project budgets and some funding dates have been updated.

A report comparing the differences between the June 25<sup>th</sup> information and the current information is provided for reference.

- 1. No project that was included in Referendum Plan has been deleted as a result of this action. Some projects have been rescheduled due to lower enrollment projections and/or funding.
- 2. No changes were made which would cause the District to violate School Concurrency, however, it is possible that some modulars, which are counted towards permanent capacity, may be needed at a few schools in order to meet the required Level of Service.
- 3. Most projects are funded in two fiscal years. The first fiscal year funding typically covers the cost of pre-construction activities including planning and design, and the second fiscal year of funding covers construction and furnishings.

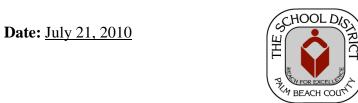

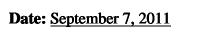
